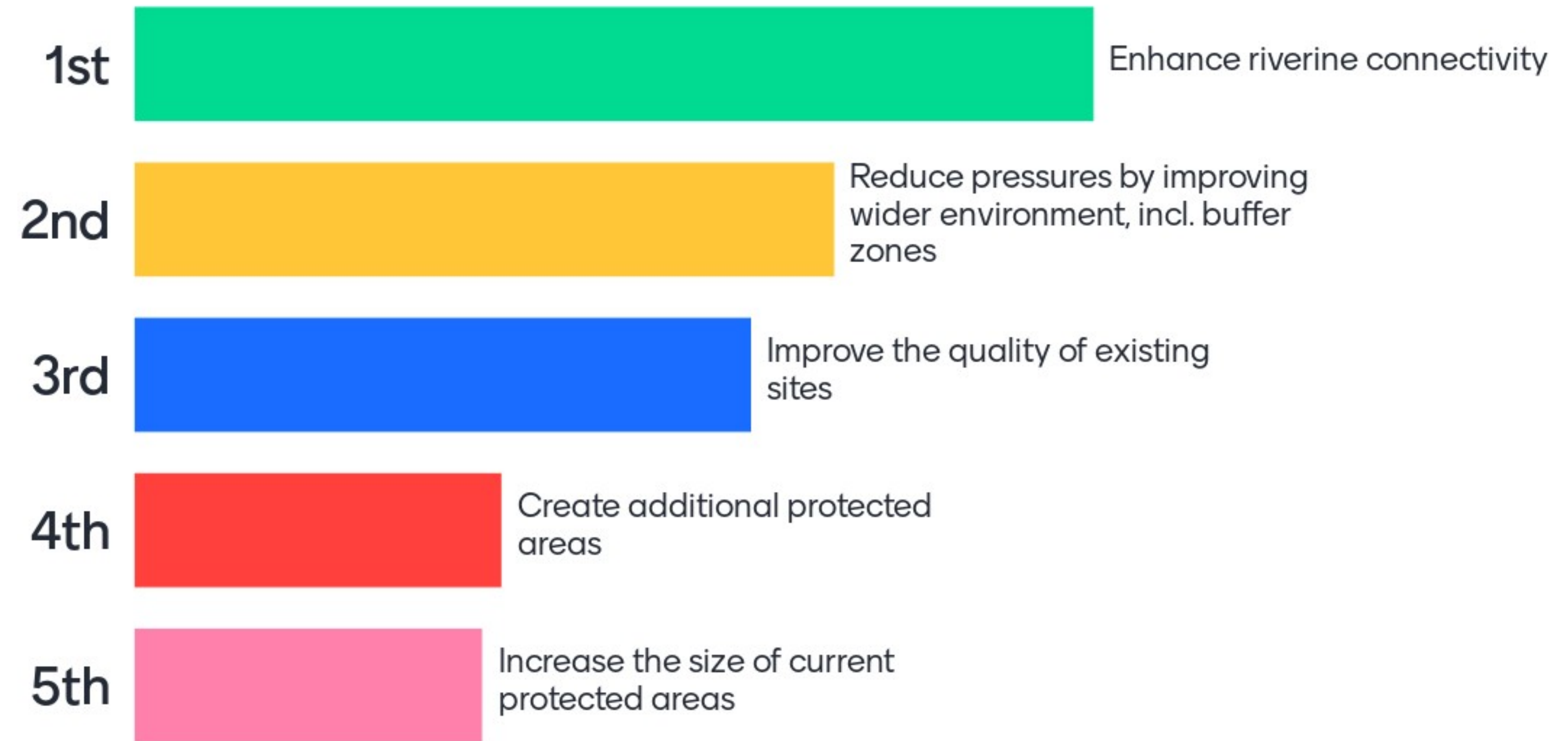

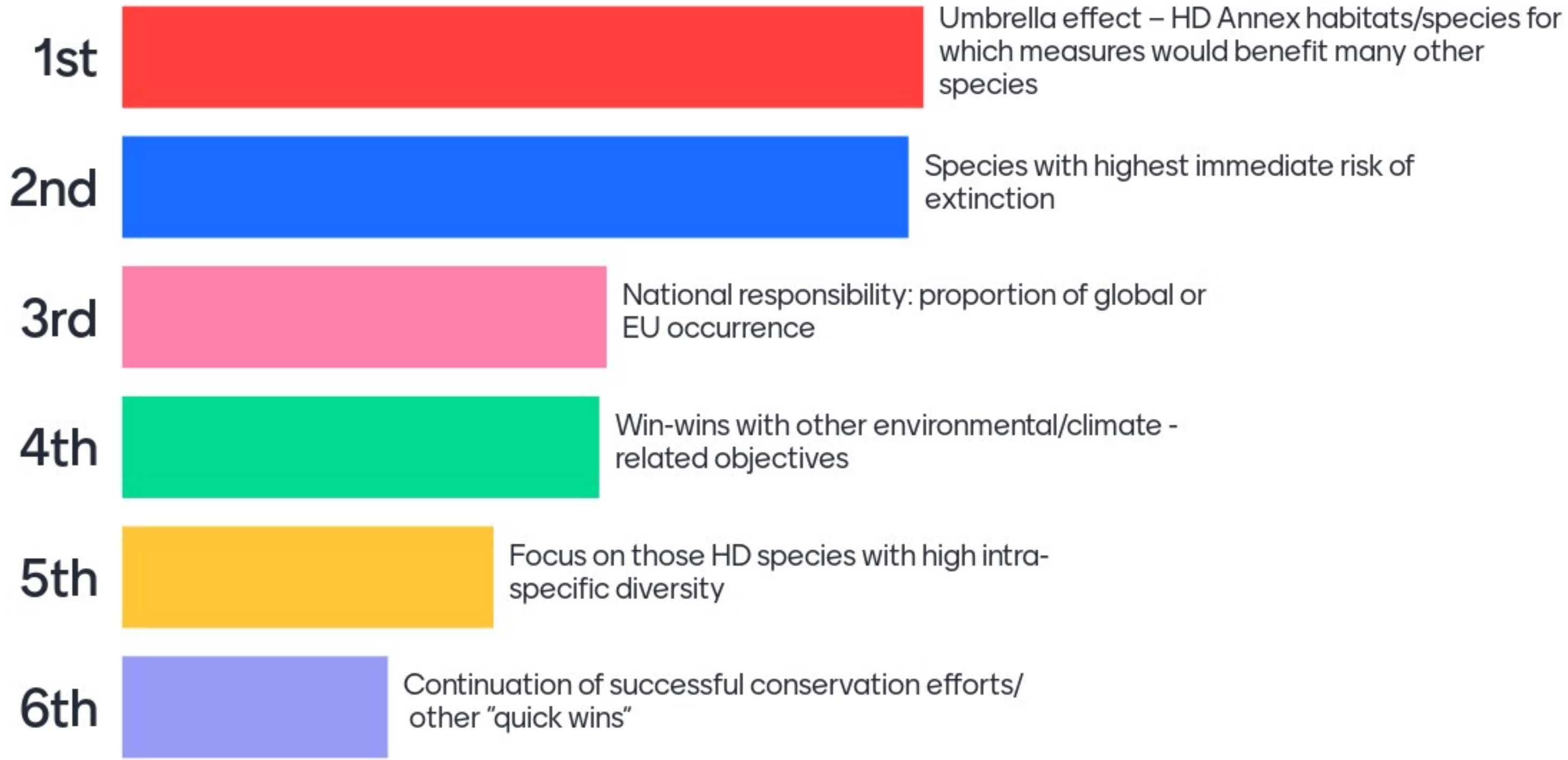

More wine

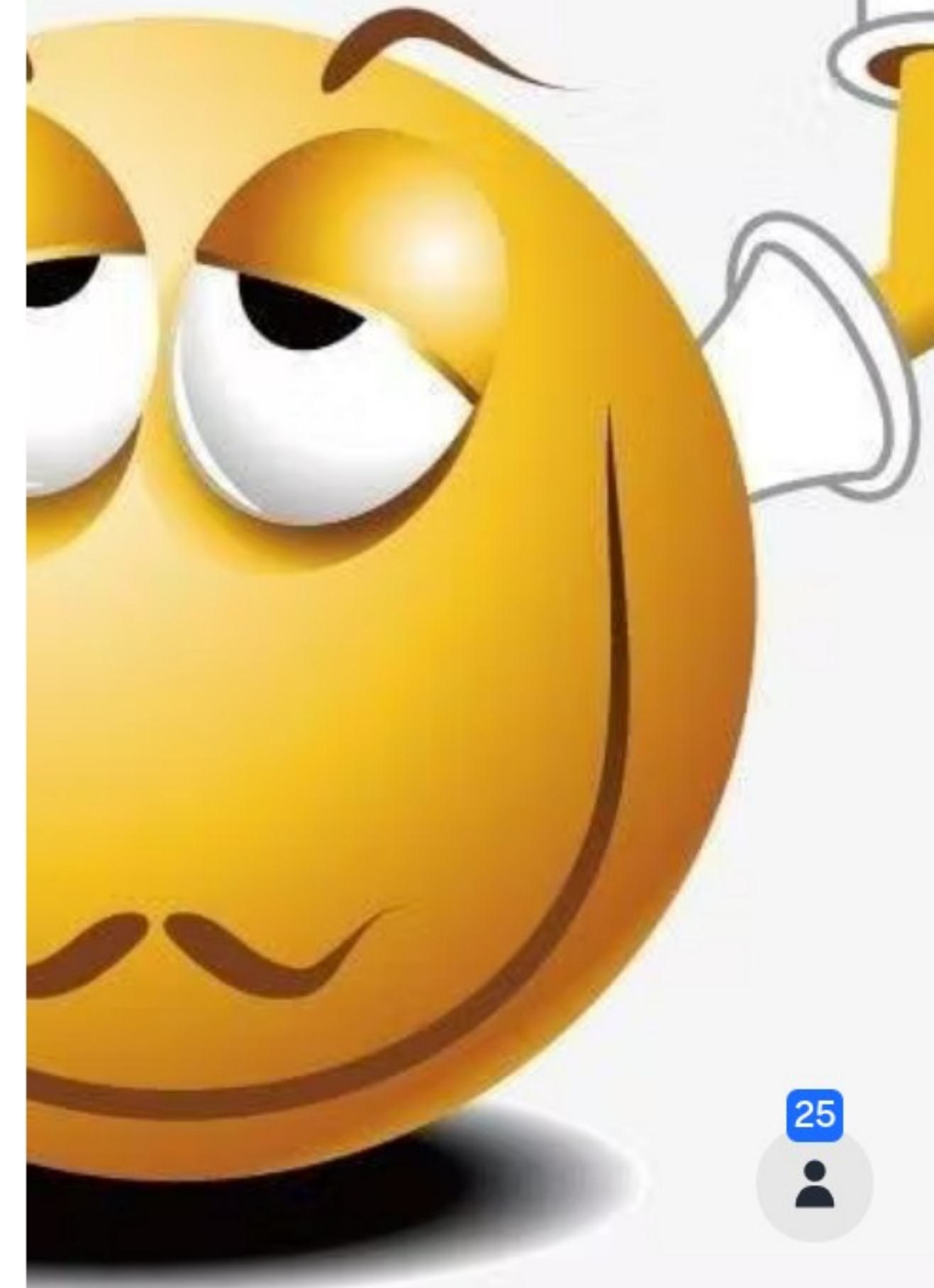
Less short notice for such an important event.

Stronger collaboration among stakeholders and communities

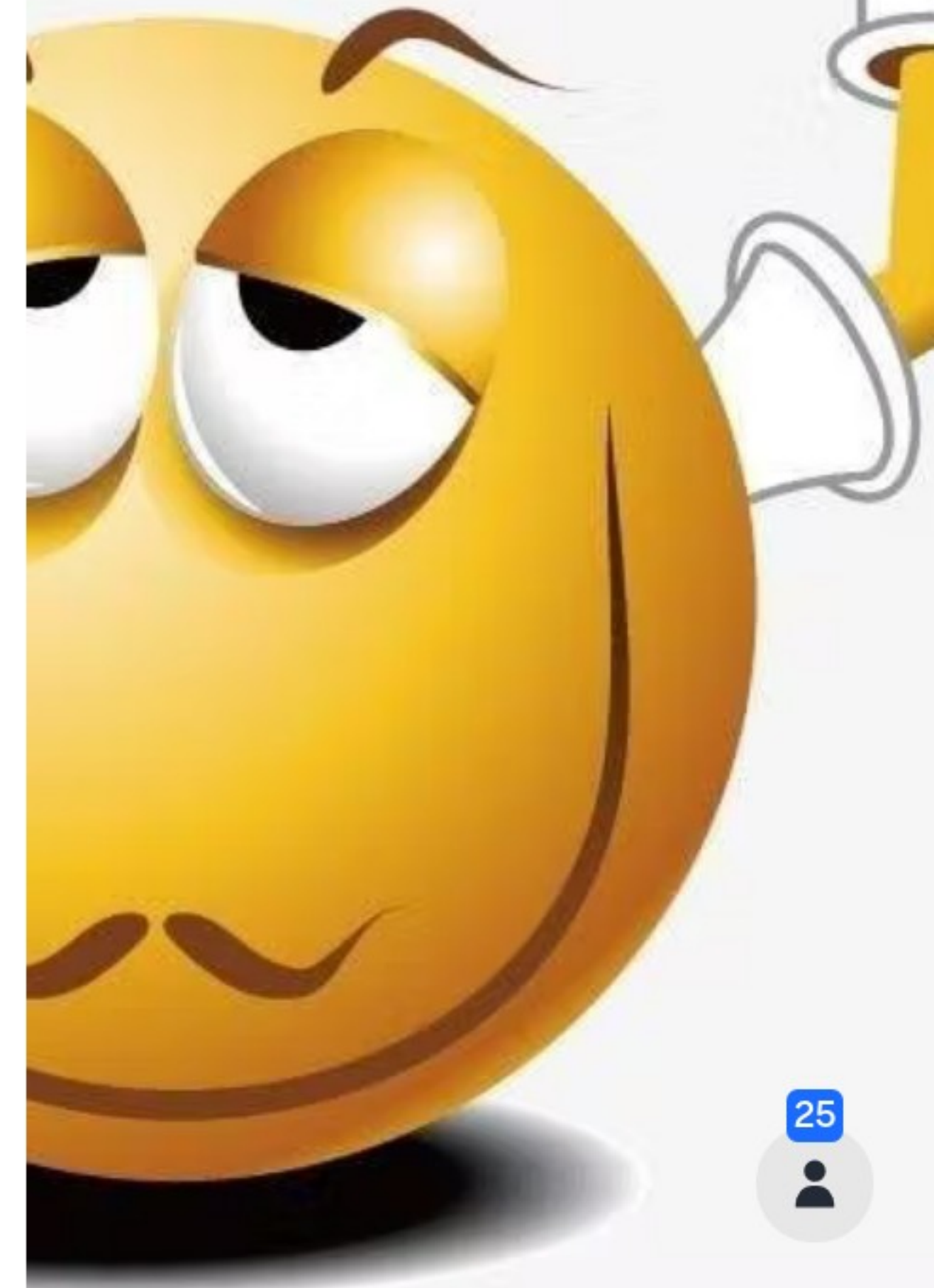
Communication on the paths to influence policy
